**Objection to Planning Application: C/01/94  
Land to east of Calton Lane, Airton, Skipton**

**Full planning permission for construction of equipment and materials store (on top of existing timber deck) for market gardening enterprise and landscape maintenance; retention of composting toilet, hardstanding and drainage with resulting footpath (part retrospective**

Dear Mr Davis

**Friends of the Dales objects to this application for the following reasons:**

The development as proposed is inappropriate for the location. In the Design and Access Statement the applicants point out that they “have recently acquired a 20-acre plot and are establishing a market gardening business there”. Even though the planning application is clearly intended for the construction of “Equipment and materials store for market gardening enterprise and landscape maintenance, and retention of composting toilet, hardstanding, and drainage with resulting footpath.” no details are provided for these future plans which may significantly impact on this unspoiled site.

Leaving aside for the moment that the site is totally inappropriate for market garden cultivation due to its steepness with possible soil erosion and generally poor soil, the development proposed in this application would be particularly harmful on this highly sensitive site in this unspoiled part of the Aire Valley, along which the Pennine Way runs. In addition, there is nothing in the application that tells us about what is anticipated in terms of access to the site for deliveries, traffic generation or any other aspect of running such a land-based activity, should a market garden application come forth.

The square box building that is illustrated in the application is of poor proportions and atypical materials which would have an adverse impact on both the visual quality of the valley and the local landscape character.

Those parts of the application that have already been installed without the benefit of planning approval (the ugly hut, the toilet and the hard standing) should be removed so that the site can return to its previous state as soon as possible. We are also concerned that the access point has been insensitively upgraded to a substantial gate which does not figure in the application.
