Objection Planning Application C/62/650A High Mearbeck Farm Barn, Long Preston

Full planning permission for change of use of land to form domestic curtilage in association with the barn conversion approved by reference C/62/650 and erection of double garage with ancillary storage space

Dear Ms Thompson Friends of the Dales **objects** to this application.

When the original planning application for the conversion of this barn was submitted Friends of the Dales did not comment. It was a field barn situated next to the track up to Mearbeck, in clear view of the A65, but within policy. We judged it to be a fairly neat and restrained conversion but are now concerned that the original plan is considered inadequate as the new application requests the doubling of the curtilage and adding a double garage. It is claimed that this is necessary for a dwelling in a rural location.

The planning permission is conditional, and one of the conditions is to **remove permitted development rights** in order to retain control over subsequent development. We may need to remind ourselves that this is a conservation policy, the aim being to re-purpose traditional buildings in such a way that retains their historic interest and their contribution to the historic landscape; it is not about creating dwellings in open countryside.

The new area of curtilage shown on the plan can, in due course, present additional problems. One of the converted barns on the road between Otterburn and Airton, though originally within policy and sensitively converted not that long ago, has now acquired four additional structures: a horse barn, two holiday huts and a large above-ground swimming pool, all randomly dotted around the field. Other barn conversions within the YDNP have seen similarly large extensions.

Friends of the Dales are **objecting to this application** as it must not become acceptable to override the original plans in this way and extend curtilages/add on buildings, etc., thus negating the original aims of the policy.
